## TINTING

Do not tint this product.

#### COVERAGE

100–250 sq. ft. per gallon (9.3–23 m<sup>2</sup>). Rates will vary depending on porosity of the surface.

#### **DRYING TIME**

Dries to touch in 1 hour. Time will vary depending on temperature and humidity. Recently applied Cabot<sup>®</sup> Waterproofing may remain slick, even when dry, until surface has been exposed to general weathering (rain and sun) for several days.

# SURFACE PREPARATION

Surfaces should be clean, porous and free of any previous finishes. To test for porosity, apply a few drops of water to the substrate. The surface is ideal for application if water can be quickly absorbed. Use Cabot<sup>®</sup> Problem-Solver<sup>®</sup> Wood Cleaner in order to remove dirt, mildew, stains, algae stains and other foreign matter. Use Cabot<sup>®</sup> Problem-Solver<sup>®</sup> Wood Brightener to easily remove extractive bleeding as well as nail and metal rust stains. Cabot<sup>®</sup> Problem-Solver<sup>®</sup> Wood Stripper can be used to remove coatings from surfaces to be treated. New masonry, stucco and concrete must be cured for a minimum of 30 days. Always apply to a small test area and allow to dry.

# LEAD WARNING

### **APPLICATION**

Shake container thoroughly before using. Apply liberally and evenly using a low-pressure sprayer, nylon or synthetic brush, roller, or by dipping. When using a sprayer, be sure to back-brush or roll immediately after spraying. To avoid streaking, start at the bottom and spray toward the top. **One coat is recommended.** Reapply seasonally or every 1–2 years depending on exposure. Use caution when standing or walking on surfaces still wet after the application of Cabot<sup>®</sup> Waterproofing, as the surface may be very slippery.

Airless Spray: Recommended tip sizes and adjustments are 1000–1500 PSI, 0.013–0.015" tip with fan width of 8–10". These recommendations are a starting point only. Due to variability in sprayers, we recommend testing your spray pattern and flow before proceeding. If spraying large surfaces, be sure to back-brush or roll immediately after spraying. When using HVLP spray equipment, see manual for proper set-up instructions.

#### RESTRICTIONS

For exterior use only. Do not apply when air or surface temperature is below 40 °F or may fall below 40 °F for 24 hours after application. To stain or paint over surfaces treated with Cabot<sup>®</sup> Waterproofing, allow a period of up to 12 months for the surface to sufficiently weather. Allow the surface to dry for 6 hours before contact with water. Do not thin or combine with any other products. Do not use steel wool on surfaces that are to be coated with this product. Do not apply over painted or sealed surfaces.

## MAINTENANCE

UV rays (sunlight) and moisture (rain/snow/dew) are wood's natural enemies, so minimize exposure. Evaluate finish each spring and maintain as needed. Finish durability depends upon weather, wear and other local conditions, but finish typically lasts 1–2 years.
