RE: Annual California Proposition 65 Notice to Customers

Dear Control Solutions, Inc. Distributor,

As a distributor of Control Solutions, Inc. (CSI) products, we are providing you with annual notice of requirements around the sale of certain products into the state of California. CSI has 25 products registered in the state of California which contain Proposition 65 chemicals. If you are aware that these 25 products are purchased by consumers and not for occupational use, a warning must be provided to the consumer prior to the purchase of these products. CSI has elected not to include an on-product warning as this is a geographic requirement specific to the state of California.

If you are an internet distributor, the included warning statements must be added to your website for the appropriate products if the products could be ordered and shipped to California. Per California proposition 65 regulations, Title 27, Article 6, § 25602. Consumer Product Exposure Warnings – Methods of Transmission:

(b) For internet purchases, a warning that complies with the content requirements of Section 25603(a) must be provided by <u>including either the warning or a clearly marked hyperlink using the word "WARNING" on the product display page, or by otherwise prominently displaying the warning to the <u>purchaser prior to completing the purchase</u>. If an onproduct warning is provided pursuant to Section 25602(a)(4), the warning provided on the website may use the same content as the on-product warning. For purposes of this subarticle, a warning is not prominently displayed if the purchaser must search for it in the general content of the website.</u>

If you are aware of product on retail shelves in the state of California, the included warning statements must be posted on a sign, shelf tag, or shelf sign, for the consumer product at each point of display of the product. The included warning statements can be printed and affixed to the shelf below the product. Per California proposition 65 regulations, Title 27, Article 6, § 25602. Consumer Product Exposure Warnings – Methods of Transmission.
